An administrative fee of EUR 40 is charged for the issue and/or rescreening for the purposes of the badge. A one-off guarantee sum of EUR 60 is charged for the issue of a new badge and this shall be refunded when the badge is returned, to the extent that it was subject only to normal wear and tear. The cost will be invoiced to the company. Earlier guarantee sums of EUR 10 will be kept.

Statement by the badge holder

I, the undersigned, consent to the performance of a background security check for the issue of an airport identification badge. **This consent is valid also for any subsequent investigation aimed at verifying that the conditions required for maintaining the airport identification badge are still fulfilled.** This agreement may be withdrawn at any time by the person concerned who no longer wishes to undergo security screening or to hold an airport identification badge. I also declare on my honour that the information given in this document is correct and complete and I undertake to notify without delay any change or other information relating to security which may be requested by the competent services. I declare that I have received training in unescorted access to CPSRA and in security awareness.

The badge must be worn visibly at all times in the secure areas and on airside. The bearer of the badge relieves Antwerp Airport NV of all responsibility during his/her stay in its facilities. He/she enters the secured area and airside at his/her own risk and is there solely for the purpose of performing his/her duties.

Consent of the person for whom the badge is requested**(Act of 11 December 1998 on classification and security clearances)**

Pursuant to the applicable provisions of the European and national aviation security regulations, only persons who have undergone a prior security background check may be employed in the secure area of airports used for international air traffic. This screening shall cover a minimum period of five years from the date of application. The check must be repeated at least every five years. The person concerned must agree to this investigation and take note of the decision of the Director-General DGLV of 23/06/2009.

The personal data are processed for security purposes in a government file declared to the Commission for the Protection of Privacy and managed by Antwerp Airport. The persons concerned may at any time consult their personal data for the purpose of, perusing and possibly correcting them (Law 08/12/1992). The person who does not want to be subjected to a safety verification may at any time indicate this by ticking the box below in accordance with Art. 30bis of the Royal Decree of 24 March 2000 and by sending it back by registered mail to FOD Mobility and Transport - BCAA. If the safety certificate or safety advice is required for an access, authorization, permit, appointment or appointment, the explicit refusal to be subjected to verification means that this access, authorization, permit, appointment or appointment cannot be granted. Explanations can be requested from FOD Mobility and Transport - BCAA.
